#### PROCEDURE FOR TAX REGISTRATION AND PAYMENT

Taxes, Levies, Fees, Charges, and Rates (Administered and Collected by the Service) Order as per provisions of the Law No. 4 of 2019 (Jigawa State Revenue Harmonization, Consolidation and Codification Law) and other extant

### Tax registration and payment process in Jigawa State

Individuals and businesses operating in Jigawa State are expected to pay taxes to the Jigawa State Internal Revenue Service.

Taxes can be paid either online or in-person at the tax office. The following are procedures:

#### Service 1: Procedure of application for Tax Identification Number (TIN)

All individuals and businesses are expected register to obtain their Tax Identification Number (TIN) in order to make the relevant tax payments.

To obtain the TIN, the following documents are required:

#### **Individuals**

- Proof of address
- Identification document
- Evidence of date of birth:
- Email address
- National Identity Number
- Bank Verification Number

### Corporates

- Corporate Affairs Commission Certificate
- Registration Number
- Organization type
- Identification document

**Step 1**: Visit the Joint Tax Board TIN registration website: <a href="www.tin.jtb.gov.ng">www.tin.jtb.gov.ng</a> and make your application with the information/documents above.

• The applicant TIN number will be sent via email within 24 Hours

#### Manual Procedure for payment of taxes

According to the (Law no 4 of 2019) Jigawa State Revenue Codification and Consolidation passed by the State House of Assembly, gives the Board some powers to set a solution on all taxes and levies matter within Executive power given to the Executive Chairman.

# 2. Review of application

- o An officer from the Jigawa State Internal Revenue Service will go through and contact the taxpayer applicant within three days of receiving your application for assessment

# 3. Compliance checks:

o The Jigawa State Internal Revenue Service will review your application and perform legal, regulatory and compliance checks to ensure all is in order. This process will be completed within 72 hours

### 4. Completion of assessment:

o Taxpayer will be not ified by the Office via email or phone on completion of the assessment and the applicable taxes to be paid

## 5. Proceed for payment

Payment should be done by filing bank teller in-person in order to make the relevant tax payment.

### **6.** Collection of receipt

Then the tax payer proceeds to the JIRS Payment and verification unit Office and collect signed printed receipt @ JIRS Revenue Accounting and Government Business Department.

- Log on to www.jirs.gov.ng
- Click on Generate Invoice
- Put your JTIN (Optional)
- Fill the information on the page
- PUT PAYER NAME
- Put email address
- Select tax MDA
- Select payment name ( Item of Tax to pay)
- Date from
- Date to
- Put amount
- Select payment Center HEAD QUARETS
- Click on Generate
- Gate way (Remita)
- Click on Pay INVOICE Now

- Select 1 Payment Method
- o Pay the money from your Bank.
- Process Completed.

NB: All this can be done within the timeline of 30minute @ Central Cashier's Office, Department of Revenue Accounting And Government Business JIRS at any of the offices.

### Step 2

### Receipt or evidence of payment

Payment process can be completed within a time line of 2 to 3 hours successfully. Receipt will be sent immediately into the taxpayers email. Then the tax payer proceeds to the JIRS Payment and verification unit Office and collect signed printed receipt @ JIRS Revenue Accounting and Government Business Department.
